**AMENDMENT NO. 5 TO CONTRACT NO. SP472A-17**

**BETWEEN**

**SOUTHERN CALIFORNIA REGIONAL RAIL AUTHORITY**

**AND**

**MBI MEDIA**

**FOR**

**PUBLIC AFFAIRS SUPPORT SERVICES**

This Contract Amendment, effective November 1, 2019 is entered into by and between the Southern California Regional Rail Authority (hereinafter called "Authority") and MBI Media (hereinafter called "Contractor"). The Authority and Contractor may collectively be referred to as the "Parties".

**RECITALS**

**WHEREAS:**

- I. The Parties entered into an agreement for Public Affairs Support Services on April 13, 2017.
- II. Effective October 16, 2017 the Authority amended the contract under Amendment No. 1 to revise Exhibit 1, Cost Schedule, to reflect changes in staff.
- III. Effective July 20, 2018 the Authority amended the contract under Amendment No. 2 to exercise the first one-year option to extend the period of performance to June 30, 2019 and increase contract funding authorization amount by \$37,500, for a new cumulative not-to-exceed contract funding authorization of \$287,500.
- IV. Effective November 9, 2018 the Authority amended the contract under Amendment No. 3 to increase contract funding authorization amount by \$500,000, for a new cumulative not-to-exceed contract funding authorization of \$787,500.

- V. Effective April 9, 2019 the Authority amended the contract under Amendment No. 4 to exercise the second one-year option to extend the period of performance to June 30, 2020.
- VI. The parties now desire to amend the contract to add a subcontractor.

NOW, THEREFORE, the Parties hereby amend the Contract as follows:

- I. Amend Article 10, SUBCONTRACTING to add The Walking Man, Inc. as a subcontractor:


