This Contract Amendment, effective July 1, 2017 is entered into by and between the SOUTHERN CALIFORNIA REGIONAL RAIL AUTHORITY (hereinafter "Authority") and UNIVERSAL PROTECTION SERVICE, LP DBA ALLIED UNIVERSAL SECURITY SERVICES (hereinafter "Contractor/Consultant").

**R E C I T A L S**

**WHEREAS:**

- I. Authority and Contractor/Consultant entered into an Agreement for Security Services for Metrolink on February 26, 2016.
- II. Effective August 31, 2016, the Authority amended the contract under Amendment No. 1 to include Article No. 34, Workplace Drug and Alcohol Testing Program.
- III. The Authority hereby amends the Agreement under Amendment No. 2 to reflect AlliedBarton Security Services merged with Universal Protection Service, LP DBA Allied Universal Security Services and revise Article 5, Notification, to replace name and address under Agreement to Universal Protection Service, LP DBA Allied Universal Security Services.

**NOW, THEREFORE, Authority and Contractor/Consultant hereby:**

- I. Amend the Agreement to acknowledge and reflect AlliedBarton Security Services merged with Universal Protection Service, LP DBA Allied Universal Security Services.


III. As hereby amended, the Contract remains in full force and effect.
