FOR CALL BOX MAINTENANCE SERVICES AND PROCUREMENT

This Contract Amendment, effective August 11, 2017 is entered into by and between the SOUTHERN CALIFORNIA REGIONAL RAIL AUTHORITY (hereinafter "Authority") and CASE SYSTEMS, INC. (hereinafter "Contractor/Consultant").

RECITALS

WHEREAS:

- I. Authority and Contractor/Consultant entered into an agreement for Call Box Maintenance Services and Procurement on June 24, 2016.
- II. The Authority, hereby amends the contract under Amendment No. 1 to increase the contract authority by \$50,000 for a total not-to-exceed contract funding authorization of \$250,000.

NOW, THEREFORE, Authority and Contractor hereby:

- I. Amend Article 3,B, Payment to delete in its entirety and replace to read as follows:

3. PAYMENT

B. Authority's maximum cumulative payment obligation under this Agreement shall not exceed Two Hundred Fifty Thousand Dollars (\$250,000), including all amounts payable to Contractor for all costs, including but not limited to direct labor, other direct costs, subcontracts, indirect costs including but not limited to leases, materials, taxes, insurance, and profit.

II. As hereby amended, the Contract remains in full force and effect.
