AMENDMENT NO. 1 TO CONTRACT NO. L166-15

BETWEEN

SOUTHERN CALIFORNIA REGIONAL RAIL AUTHORITY

AND

SHAW, YODER, ANTWIH, INC

FOR

STATE LEGISLATIVE REPRESENTATION SERVICES

This Contract Amendment, effective November 17, 2017 is entered into by and between the SOUTHERN CALIFORNIA REGIONAL RAIL AUTHORITY (hereinafter "Authority") and SHAW, YODER, ANTWIH, INC (hereinafter "Contractor/Consultant").

RECITALS

WHEREAS:

- I. Authority and Consultant entered into an agreement for State Legislative Representation Services on November 13, 2015.
- II. The Authority hereby amends the contract under Amendment No. 1 to exercise the first one-year option to extend the period of performance to December 31, 2018 and increase contract funding authorization amount by \$120,000, for a new cumulative not-to-exceed contract funding authorization of \$360,000.

NOW, THEREFORE, Authority and Consultant hereby:

- I. Amend Article 2, Period of Performance to delete in its entirety and replace to read as follows:

2. PERIOD OF PERFORMANCE

The period of performance shall be from January 1, 2018 to December 31, 2018 with an option for two one-year that may be exercised at the sole

discretion of AUTHORITY, unless amended by mutual agreement of both parties through a written amendment to this Contract or unless earlier terminated pursuant to the provisions of this Contract.

II. Amend Article 3, PAYMENT, Paragraph B, as follows:

3. PAYMENT

AUTHORITY's maximum cumulative payment obligation under this Agreement shall not exceed Three Hundred Sixty Thousand Dollars (\$360,000), including all amounts payable to CONSULTANT for all costs, including but not limited to direct labor, other direct costs, subcontracts, indirect costs including but not limited to leases, materials, taxes, insurance, and profit.

III. As hereby amended, all other terms and conditions shall remain the same and in effect.
