

AMENDMENT NO. 2 TO CONTRACT NO. L166-15 BETWEEN

SOUTHERN CALIFORNIA REGIONAL RAIL AUTHORITY

AND

SHAW, YODER, ANTWIH, INC.

FOR

STATE LEGISLATIVE REPRESENTATION SERVICES

This Contract Amendment, effective November 9, 2018, is entered into by the Southern California Regional Rail Authority ("Authority") and Shaw, Yoder, Antwih, Inc. ("Contractor"). The Authority and the Contractor may collectively be referred to as the "Parties".

WHEREAS

The Parties entered into a contract for State Legislative Representation Services on November 13, 2015.

The Parties amended the Contract under Amendment No. 1 to exercise the first one-year option and increase contract funding authorization.

The Parties now desire to amend the Contract to exercise the second one-year option, increase the contract authority, and revise the insurance requirements.

Therefore, the Parties agree to amend the Contract as follows:

- I. Article 2, Period of Performance, is revised to delete in its entirety and replace with:
 - The period of performance will be from January 1, 2016 to December 31, 2019 with a one-year option that may be exercised at the sole discretion of the Authority, unless amended by mutual agreement of both parties through a written amendment to this Contract or unless earlier terminated pursuant to the provisions of this Contract.
- II. Article 3, Payment, Section B, is revised to delete in its entirety and replace with:

The Authority's maximum cumulative payment obligation under this Contract will not exceed \$480,000, including all amounts payable to the Contractor for all costs, including but not limited to direct labor, other direct costs, subcontracts,

indirect costs including but not limited to leases, materials, taxes, insurance, and profit.

- III. Article 13, Insurance, Section E, Employer's Practices Liability, is deleted in its entirety.
- IV. Except as set forth in this Amendment, the Contract remains in full force and effect.

Amendment No. 2 – Contract Term Extension, Funding Increase, and

Insurance Update

Contract No L166-15 with Shaw, Yoder, Antwih, Inc for State Legislative Representation Services was entered on November 13, 2015. The term of the contract was from January 1, 2016 to December 31, 2017 with three one-year options for a not-to-exceed amount of \$240,000.

Amendment No. 1 was issued on November 17, 2017 to exercise the first one-year option to extend the period of performance to December 31, 2018 and increase contract funding authorization in the amount of \$120,000 for a new not-to-exceed amount of \$360,000, per enclosed Board Item 9.

The purpose of Amendment No. 2 is to exercise the second one-year option to extend the period of performance to December 31, 2019, increase the contract funding authorization amount by \$120,000, for a new total not-to-exceed contract funding authorization of \$480,000, per enclosed Board Item 8, and to delete Employer's Practices Liability insurance requirement from Article 13, Insurance, Section E.
