AMENDMENT NO. 1 TO CONTRACT NO. L167B-17

BETWEEN

SOUTHERN CALIFORNIA REGIONAL RAIL AUTHORITY

AND

KADESH & ASSOCIATES

FOR

FEDERAL LEGISLATIVE REPRESENTATION SERVICES

This Contract Amendment, effective December 8, 2017 is entered into by and between the SOUTHERN CALIFORNIA REGIONAL RAIL AUTHORITY (hereinafter "Authority") and KADESH & ASSOCIATES (hereinafter "Contractor/Consultant").

RECITALS

WHEREAS:

- I. Authority and Contractor/Consultant entered into an agreement for Federal Legislative Representation Services on January 30, 2017.
- II. The Authority hereby amends the contract under Amendment No. 1 to exercise both one-year options remaining on the contract to extend the period of performance to December 31, 2019 and increase contract funding authorization in the amount of \$240,000.

NOW, THEREFORE, Authority and Contractor/Consultant hereby:

- I. Amend Article 2, Period of Performance to delete in its entirety and replace to read as follows:

2. PERIOD OF PERFORMANCE

The period of performance shall be from January 30, 2018 to December 31, 2019, unless amended by mutual agreement of both parties through

written amendment to this Contract or unless earlier terminated pursuant to the provisions of this Contract.

- II. Amend Article 3, PAYMENT, Paragraph B, as follows:

3. PAYMENT

AUTHORITY's maximum cumulative payment obligation under this Agreement shall not exceed Three Hundred Sixty Thousand Dollars (\$360,000), including all amounts payable to Contractor/Consultant for all costs, including but not limited to direct labor, other direct costs, subcontracts, indirect costs including but not limited to leases, materials, taxes, insurance, and profit.

- III. As hereby amended, all other terms and conditions shall remain the same and in effect.
