### **METROLINK'S NEW TIER 4, LOCOMOTIVES NOW IN SERVICE!**

As of Friday, February 22, 2019, 23 locomotives have been delivered to Keller Yard.

- 15 locomotives are available for service.
- 8 additional locomotives are undergoing installation and testing of PTC equipment



## AGENCY ANNOUNCEMENTS

Metrolink recently installed Automated External Defibrillators (AEDs) on all trains operating in the agency's six-county service region. An AED is a portable electronic device that automatically diagnoses certain life-threatening cardiac conditions and treats them through the application of electricity.

The quick use of an AED can save a person's life in the event of a sudden cardiac arrest and having them on trains maintains safety for all rail passengers, Metrolink has posted an instructional [video](#) to its web site if you are interested in learning how to use an AED.
