Temporary Daytime Active Train Testing (GLENDDORA, SAN DIMAS, LA VERNE, & POMONA) AUGUST 1 - AUGUST 3, 2024 (THREE-DAYS ONLY)

CONSTRUCTION ACTIVITY

The ongoing active train testing for the Foothill Gold Line light rail project that began in July, and has occurred mostly at night between San Dimas and Pomona, will temporarily transition to daytime hours and will also begin to take place through the city of Glendora for the first time. **During the three-day period of Thursday, August 1st thru Saturday, August 3rd, trains will run at higher speeds (up to 55 MPH) between San Dimas and Pomona, and will also begin running through the city of Glendora for the first time (ranging in speed from 5 to 55 MPH).** Active train testing is expected to move back to nighttime shifts beginning Monday night, August 5th and continue throughout the four-city corridor mostly at night through the end of 2024 (as noted on the ongoing initial train testing notice). Local Police and County Sheriff support will continue during these operations to direct traffic at all grade crossings (see map below).

WHEN

Active Train Testing will occur during daytime hours from Thursday, August 1st thru Saturday, August 3rd as follows:

- **Thursday, August 1st (San Dimas, La Verne, & Pomona):** High speed train testing between Gladstone St. and Garey Ave - Daytime testing hours: 7:00 AM - 4:00 PM (longer hours may be needed)
- **Friday, August 2nd & Saturday, August 3rd (Glendora):** Train testing at all speeds between Barranca Ave. and Gladstone St. - Daytime testing hours: 7:00 AM - 4:00 PM (longer hours may be needed)

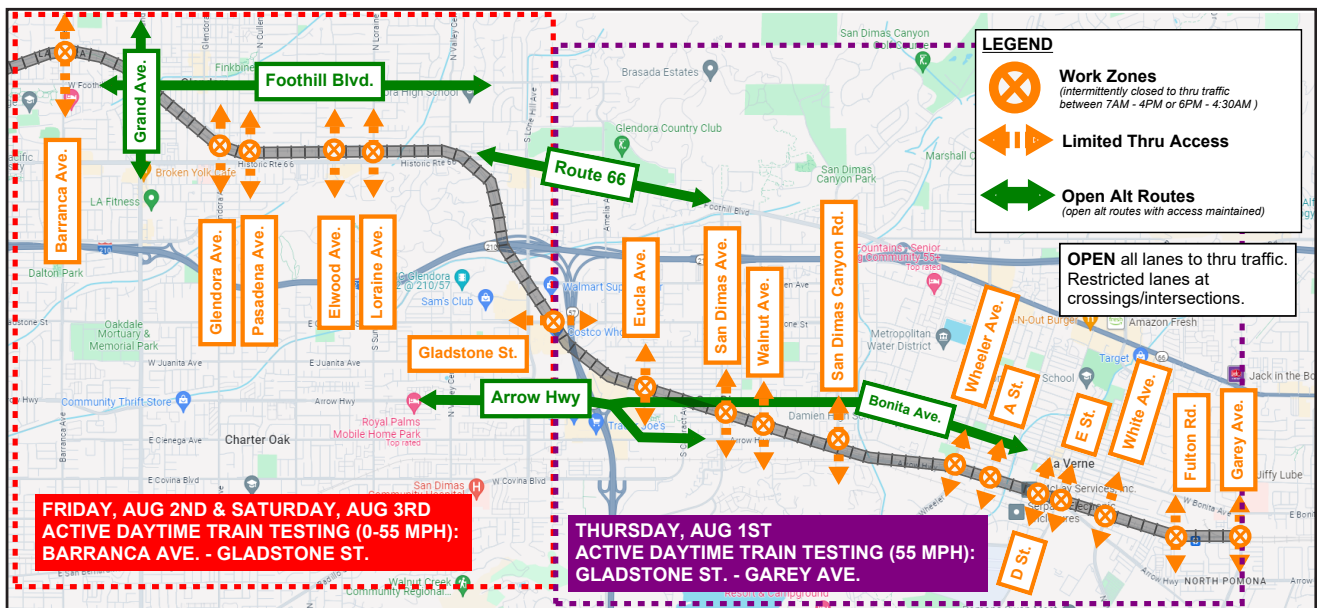
NOTE: Additional daytime/nighttime testing hours may occur during this period, including on Sunday if needed; followed by nightly train testing resuming between Glendora and Pomona at high speeds through the end of 2024.

TRAFFIC ADVISORIES

- **Trains will be running at high speeds (up to 55 MPH) during daytime hours.**
- Crossing gate arms will drop throughout the work shift when testing is taking place.
- Vehicular and pedestrian traffic will be stopped when gates are down and resume as normal once gate arms are raised.

NOTE TO RESIDENTS

- Never walk on the train tracks, go around the lowered gates, and follow all safety instructions.
- Obey all warning signs and watch for trains from both directions.

(CITIES OF GLENDORA, SAN DIMAS, LA VERNE, & POMONA)

JULY 8 - DECEMBER 31, 2024

CONSTRUCTION ACTIVITY

As part of the 9.1-mile Foothill Gold Line light rail project, active train testing will begin to take place daily and nightly throughout the project (from between Barranca Ave in the City of Glendora to past Garey Ave in the City of Pomona) starting Monday, July 8th and continuing through the end of 2024. Testing will occur Monday thru Friday, specifically during shifts as shown below. Regularly scheduled construction activities will also continue. Train testing, using an active train, will occur with the help of local police departments and the Los Angeles County Sheriff directing traffic at the grade crossings. To limit noise, the grade crossing bells will be disconnected as much as possible during this testing period and the train operators will use their optional “quiet-zone” horns as much as possible. Please follow all safety instructions and be aware of active trains and dropping crossing gates at railroad crossings project wide.

WHEN

Beginning Monday, July 8th and continuing daily/nightly thru December 31st, 2024. Testing will occur Monday - Friday as follows:

- **July 8th - 12th:** Daily testing; 7:00 AM - 4:00 PM (longer hours may be needed occasionally)
- **July 15th - December 31st:** Nightly testing; 6:00 PM - 4:30 AM (longer hours may be needed occasionally)

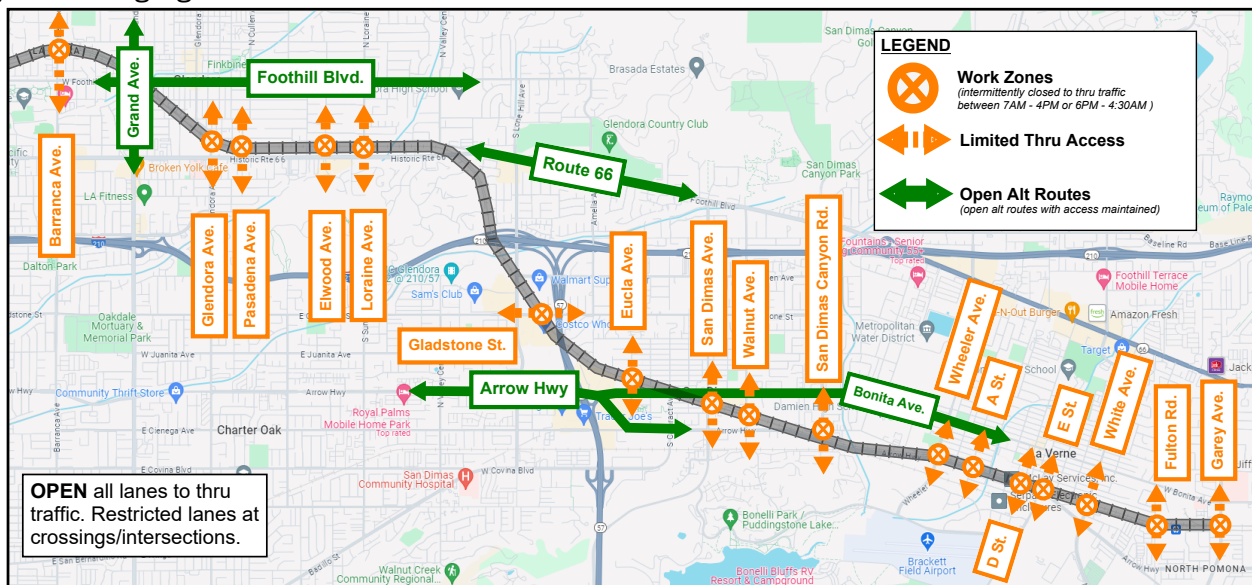
NOTE: Additional daytime/nighttime testing may occur, including on Saturdays and Sundays if needed.

TRAFFIC ADVISORIES

- Crossing gate arms will drop throughout the work shift when testing is taking place.
- Vehicular and pedestrian traffic will be stopped when gates are down; and resume as normal once gate arms are raised.

NOTE TO RESIDENTS

- Never walk on the train tracks.
- Never go around the lowered gates and follow all safety instructions.
- Obey all warning signs and watch for trains from both directions.
