Metrolink In The Community

In November 2018, Councilmember O'Farrell's office contacted Metrolink regarding fencing that had been cut along the right-of-way. This created a danger because local children were using the railroad tracks as a short-cut over the Metrolink tracks. That same month, Metrolink's Track and Structure crew fixed the fence and cleaned up the area. In conjunction with Councilmember O'Farrell's office, the crew will once again go out at the end of January, install more secure fencing and finish cleaning up the area.
